PROCUREMENT OF NETWORK MANAGEMENT SYSTEM FOR F.Y. 2022

Whereas, on 02 December 2021, the Administrative Division issued the 1st Indorsement forwarding to the Bids and Awards Committee (BAC) the approved Purchase Request (PR) No. 021-11-203 (2022) dated 26 November 2021, amounting to Six Million Five Hundred Thousand Pesos (Php6,500,000.00), relative to the Procurement of Network Management System for F.Y. 2022;¹

Whereas, prior thereto, the BAC conducted a Pre-Procurement Conference on 11 November 2021 to determine its readiness for the procurement activity;²

Whereas, the OSG advertised the Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS);³

Whereas, in response to said advertisement, representatives from VCT Network and Data Solutions, Microdata System, and Advance Microsystems Inc. attended the Pre-Bid Conference conducted on 10 December 2021;⁴

Whereas, on 22 December 2021, during the Submission and Opening of Bids, only **Advance Microsystems Corporation** submitted its eligibility and technical requirements for evaluation;⁵

Whereas, using the non-discretionary "PASS-FAIL" criterion, **Advance Microsystems Corporation** passed the eligibility and technical requirements for the procurement;

Whereas, Advance Microsystems Corporation also submitted its financial bid amounting to Six Million Four Hundred Ninety-Five Thousand Nine Hundred Pesos (Php6,495,900.00);

Whereas, considering that **Advance Microsystems Corporation** passed the eligibility and technical requirements, and its financial bid is within the ABC, it was declared as the bidder with the single calculated bid for the instant procurement, subject to post-qualification;

Whereas, during the post-qualification, **Advance Microsystems Corp.** was found to be compliant with all the legal and technical capability requirements contained in the bid proposal documents;⁶

NOW, THEREFORE, be it resolved, as it is hereby resolved by the BAC to recommend the contract for the PROCUREMENT OF NETWORK MANAGEMENT SYSTEM FOR F.Y. 2022, amounting to SIX MILLION FOUR HUNDRED NINETY-FIVE THOUSAND NINE HUNDRED PESOS (PHP6,495,900.00), be awarded to Advance Microsystems Corporation as the Bidder with the Single Calculated and Responsive Bid.
