PROCUREMENT OF 1x100 MBPS ADDITIONAL REDUNDANT DIRECT INTERNET ACCESS FOR F.Y. 2022

Whereas, on 02 December 2021, the Administrative Division issued the 1st Indorsement forwarding to the Bids and Awards Committee (BAC) the approved Purchase Request (PR) No. 021-11-218 (2022) dated 26 November 2021, amounting to Two Million Three Hundred Seventy Six Thousand Pesos (Php2,376,000.00), relative to the Procurement of 1x100 MBPS Additional Redundant Direct Internet Access for F.Y. 2022;¹

Whereas, prior thereto, the BAC conducted a Pre-Procurement Conference on 11 November 2021 to determine its readiness for the procurement activity;²

Whereas, the OSG advertised the Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS);³

Whereas, in response to said advertisement, representatives from VCT Network and Data Solutions, Philippine Telegraph and Telephone Corp., and Converge ICT attended the Pre-Bid Conference conducted on 10 December 2021;⁴

Whereas, on 22 December 2021, during the Submission and Opening of Bids, only **Philippine Telegraph and Telephone Corporation** submitted its eligibility and technical requirements for evaluation;⁵

Whereas, using the non-discretionary "PASS-FAIL" criterion, Philippine Telegraph and Telephone Corporation passed the

eligibility and technical requirements for the procurement;

Whereas, Philippine Telegraph and Telephone Corporation also submitted its financial bid amounting to Two Million Three Hundred Seventy Six Thousand Pesos (Php2,376,000.00);

Whereas, considering that Philippine Telegraph and Telephone Corporation passed the eligibility and technical requirements, and its financial bid is within the ABC, it was declared as the bidder with the single calculated bid for the instant procurement, subject to post-qualification;

Whereas, during the post-qualification, Philippine Telegraph and Telephone Corporation was found to be compliant with all the legal and technical capability requirements contained in the bid proposal documents;⁶

NOW, THEREFORE, be it resolved, as it is hereby resolved by the BAC to recommend the contract for the PROCUREMENT OF 1X100 MBPS ADDITIONAL REDUNDANT DIRECT INTERNET ACCESS FOR F.Y. 2022, amounting to TWO MILLION THREE HUNDRED SEVENTY SIX THOUSAND PESOS (Php2,376,000.00), be awarded to Philippine Telegraph and Telephone Corporation as the Bidder with the Single Calculated and Responsive Bid.
