for the Procurement of Two (2) Brand New Passenger Vans and Three (3) Brand New Sedans

The Office of the Solicitor General (OSG) is authorized to purchase two (2) units of passenger van and three (3) units of sedans to be charged against its Continuing Appropriation for FY 2016 and FY 2017 Appropriation for Capital Outlay in the total amount of Five Million Nine Hundred Thousand Pesos (P5,900,000.00)

These passenger vans are intended for the official use of the Administrative Services to dispatch voluminous correspondences to different courts, and transport personnel to various meetings, trainings and other official business matters, while the sedans are for the next batch of Assistant Solicitors General subject to seniority.
