
SUPPLEMENTAL BID BULLETIN NO. 2017 - 011

PROCUREMENT OF PROPERTY, PLANT & EQUIPMENT AND SEMI-EXPENDABLE PROPERTIES

The following matters were clarified during the pre-bid conference conducted on December 1, 2017:

1. The delivery schedule stated in the Terms of Reference should be amended from thirty (30) days upon receipt of the Notice to Proceed to ninety (90) days upon receipt of the Notice to Proceed;

2. Under Lot 1, Item (B)(i) of the Terms of Reference for 3-seater sofa, the 11 pieces sofa should be: (a) 8 pcs. black leatherette with arms and chrome legs, and (b) 3 pcs. brown PU leatherette (1 pc. 3-seater with armrest, 1 pc. 2-seater with armrest and 1 pc. 3-seater without armrest, 220cm). Below is a sample design of the brown PU leatherette sofa:



- 3. Under Lot 1, Item (B)(ii) of the Terms of Reference for L-type sofa, the 3 pieces L-type sofa should be: (a) 1 pc. L-type (brown, size: 225x205cm, without armrest), (b) 1 pc. L-type (brown, size: 2mtrs.x140cm without armrest), and (c) 1 pc. L-type (black, size: 210x185cm without armrest);
- 4. Under Lot 1 for tables, the wood must be laminated wood melamine (color: mahogany or wedge);
- 5. Under Lot 1, Item (C)(iii) of the Terms of Reference for Office Tables for Assistant Solicitor General/Sr. Executive Table, they must be L-type

with drawers, lock, key, mobile pedestal with three (3) drawers;

6. Under Lot 1, Item (C)(iv) of the Terms of Reference for Conference Table, the conference tables must be ten (10) seating capacity and oval-shaped;

7. The prospective bidders may coordinate with Mr. Edwin Bagos of the Administrative Division for the ocular inspection of the sofas prior to the opening and submission of bids on 13 December 2017; and

8. Below is the evaluation/point system that will be followed in determining the winning bidder:

Point System:

- 1. The following items will be simultaneously considered in the evaluation of submitted bids:
 - a. Financial Bid Score 1. Bid Price

b. Technical Score

- 2. Durability

3. Design

- 2. The Financial Bid Score shall have a maximum of forty (40) points. The Technical Score for Durability shall have a maximum of forty (40) points. The Technical Score for Design shall have a maximum of twenty (20) points.
- 3. The Financial Bid Score shall be determined in accordance with the following guidelines:
- The bidder having the lowest Financial Bid shall be given a score of forty (40) as its Financial Bid Score.
- The Financial Bid Score of other bidders shall be determined in accordance with the following formula:

- The Technical Score for Durability shall be determined in accordance with the following guidelines:
- The bidder having the highest Technical Score for Durability shall be given a score of forty (40) points.
- The Technical Score for Durability of other bidders shall be determined in accordance with the following formula:

Technical Score for Durability =40* (Current Technical Score for Durability) Highest Technical Score for Durability

- 5. The Technical Score for Design shall be determined in accordance with the following guidelines:
- a. The bidder having the highest Technical Score for Design shall be given a score of twenty (20) points.
- b. The Technical Score for Design of other bidders shall be determined in accordance with the following formula:

Technical Score for Design = 20 * (<u>Current Technical Score for Design</u>)
Highest Technical Score for Design
