INVITATION TO BID

PROCUREMENT OF ENDPOINT DESKTOP MANAGEMENT SYSTEM

The **Office of the Solicitor General (OSG)**, through the FY 2020 GAA, R.A. 11465, intends to apply the sum of **Two Million Pesos (₱2,000,000.00)** being the Approved Budget for the Contract (ABC) to payment for the:

The OSG now invites bids for the procurement of Endpoint Desktop Management System with Access License for 600 units. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The bidder must have completed, within the last 3 years from the date of submission and receipt of at least one (1) single contract of similar nature amounting to at least fifty percent (50%) of the ABC; or the prospective bidder should have completed at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of the ABC; and the largest of these similar contracts must be equivalent to at least half of the fifty percent (50%) of the ABC as required.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations of R.A. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws and regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Bids must be duly received by the BAC Secretariat at the **Administrative Division 2nd FIr.**, **OSG Bldg.**, **134 Amorsolo St.**, **Legaspi Village**, **Makati City** on or before 10:25 am of **26 October 2020**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address above. Late bids shall not be accepted.

A complete set of bidding documents may be acquired by interested bidders from the OSG on **7 October 2020** between 8:00 a.m. to 5:00 p.m. until 10:00 am of **26 October 2020**, Monday to Friday, and upon payment of a non-refundable fee in the amount stated above, pursuant to the latest Guidelines issued by the GPPB.

The OSG reserves the right to accept or reject any bid and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
