

SUPPLEMENTAL BID BULLETIN NO. 2020-005

**One (1) Year Health Maintenance Organization (HMO) Program
for all Official and Employees of the Office of the Solicitor General
(OSG PR No. 020-08-088)**

TO ALL PROSPECTIVE BIDDERS:

For your information are the guidelines in determining the Lowest Calculated Bid.

1. Section 1 of **I. Premium and Payment** is amended to read:

1.The HMO shall provide for a single premium rate for each opt-in principal member. There shall be **651** opt-in principal members to be enrolled in the 2020 OSG HMO Program.

2. Section 2 of **I. Premium and Payment** is amended to read:

2.The OSG shall pay portion of the premium in the total amount of not more than Six Million Pesos (Php 6,000,000.00), which is the Approved Budget for the Contract (ABC).

3. Section 3 of **I. Premium and Payment** is amended to read:

3. Opt-in Principal members, through a special trust fund, shall pay the remaining portion of the premium in the amount of Php **4,300.00** each **or a total amount of Php2,799,300.00. This amount shall be paid, net of withholding taxes, within thirty (30) business days from enrollment and submission of ID cards to principal members.**

4. Section 4 of **I. Premium and Payment** is amended to read:

4.The OSG shall pay one-half (½) of its share **or the maximum amount of Php3,000,000.00**, net of withholding taxes, under the contract to the HMO within thirty (30) business days from enrollment and submission of ID cards to principal members. The remaining half of its share shall be paid within thirty (30) business days from the submission of the 2nd Quarterly Utilization Report.

5. The Lowest Calculated Bid will be determined based on the financial bid submitted *vis-à-vis* the ABC of P6,000,000.00, which is the share of the OSG.

6. In case of a tie, the Lowest Calculated Bid will be determined using “draw lots,” pursuant to GPPB Resolution No. 06-2005 (Appendix 11 of the IRR of R.A. No. 9184). To break the tie, the qualified bidders will draw lots with numbers 1, 2, 3, and so on. The one who gets number 1 will be considered for post-qualification. Should it qualify, it shall be declared the winning bidder. However, in the unfortunate event that the bidder who drew number 1 fails to qualify, the bidder who drew number 2 shall be notified for post-qualification. This process shall continue until a bidder shall have qualified.
