### **Resolution No. 2022-12-001**

#### **PROCUREMENT MOTORCYCLES FOR THE OFFICE OF THE SOLICITOR**

**Whereas**, on 09 December 2022, the Bids and Awards Committee (BAC) conducted the Pre-Bid Conference for the Procurement of Motorcycles for the Office of the Solicitor General (OSG) under PR No. 022-11-235.

**Whereas**, there were no interested bidders in attendance.

**Whereas**, the BAC noted that the Approved Budget for the Contract (ABC) is only **Seven Hundred Ninety Eight Thousand Pesos (Php 798,000.00)**.

**Whereas**, the said amount is within the threshold for Small Value Procurement under Negotiated Procurement per Annex "H" of the Revised Implementing Rules and Regulations of Republic Act No. 9184, viz:

**D. NEGOTIATED PROCUREMENT.** Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting Services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases:

#### **8. SMALL VALUE PROCUREMENT (SVP)**

a) **Definition.** Procurement of (a) goods not covered by Shopping under Section 52 of the IRR of RA 9184, (b) infrastructure projects, and (c) consulting services, where

the amount involved does not exceed the following threshold:

- i. For NGAs, GOCCs, GFIs, SUCs and Autonomous Region Government, One. Million Pesos (Php1,000,000.00).

**Now, therefore,** be it resolved, as it is hereby resolved by the BAC that the Procurement for Motorcycles for the Office of the Solicitor General under PR No. 022-11-235 under Competitive Bidding be **CANCELLED**, and instead **ADOPT** the Small Value Procurement under Negotiated Procurement pursuant to the Revised Implementing Rules and Regulations of Republic Act No. 9184.

The BAC resolved further that the Annual Procurement Plan be **REVISED** accordingly.
