<p><b>Section II. Instruction to Bidders</b></p> <p>5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No. 9184, the Bidder shall have at least one (1) contract similar to the Project (SLCC) the value of which, adjusted to current prices using the PSA’s CPI, must be at least equivalent to:</p> <p>a. at least fifty percent (50%) of the ABC.</p>	<p><b>Section II. Instruction to Bidders</b></p> <p><b>5.3.</b> Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No. 9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA’s CPI, must be at least equivalent to at least twenty-five percent (25%) of the ABC.</p>
<p><b>Section III. Bid Data Sheet</b></p> <p>5.3. For this purpose, contracts similar to the Project shall be:</p> <p>a. For the procurement of Expendable Supplies and Services: The Bidder must have completed a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC.</p> <p>b. Completed within three (3) years from the date of submission and receipt of bids.</p> <p>The supplier should be duly authorized to provide, sell, configure, and support the endpoint protection product it intends to offer.</p> <p>The bidder must have completed, within the last three (3) years from the date of submission and receipt of at least one (1) single contract of similar nature amounting to at least fifty percent (50%) of the ABC; or the prospective bidder should have completed at least two (2) similar contracts, and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of the ABC, and the largest of these similar contracts must be equivalent to at least half of the fifty percent (50%) of the ABC as required.</p>	<p><b>Section III.
