<b>PARTICULARS</b>	<b>DESCRIPTION</b>
<b>Function</b>	For use of Process Servers and Administrative Assistants of the OSG who by nature of their functions have to travel to remote areas not normally accessible by ordinary transport vehicles [see DBM Circular 2022-1]
<b>Performance</b>	The motorcycle is expected to aid Process Servers and Administrative Assistants of the OSG to quickly a) file and serve pleadings; and b) deliver/dispatch pertinent documents to different government agencies and private entities
<b>Environmental Interface</b>	For use of Process Servers and Administrative Assistants of the OSG within Metro Manila and nearby cities and municipalities
<b>Type/Category/Transmission</b>	Automatic or CVT / Scooter
<b>Displacement</b>	At least 150cc but not exceeding 200cc
<b>Length</b>	At least 1919mm but not exceeding 2000mm
<b>Width</b>	At least 678mm but not exceeding 800mm

<b>Curb Weight</b>	At least 113kgs but not exceeding 135kgs

<b>Fuel Supply System</b>	Fuel injection
<b>Fuel Type</b>	Gasoline
<b>Transmission Type</b>	Automatic
<b>Tire Type (Front and Rear)</b>	Radial tubeless
<b>Model</b>	2022/2023
<b>Warranty</b>	At least one year or 12,000 kms, whichever comes first.
